TOWN OF ARBORG BY-LAW NO. 11-2022

Being a By-law of the Town of Arborg to Provide Remuneration for its Mayor and Councillors

WHEREAS Section 124 of *The Municipal Act*, L.M. 1996, c. 58-Chap. M225, provides that any municipality may by by-law provide for compensation to members of Council;

AND WHEREAS Section 124(2) of said *Act* provides that a Council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district.

- (a) as compensation for attending to municipal business;
- (b) for expenses incurred while attending to municipal business; and
- (c) for any other purpose relating to municipal business that the council considers appropriate.

NOW THEREFORE the Council of the Town of Arborg duly assembled that, **effective January 1, 2023**:

- 1. The Town of Arborg shall pay to the Mayor a monthly indemnity of \$830.00 during his term of office;
- 2. The Town of Arborg shall pay to the Deputy Mayor a monthly indemnity of **\$650.00** during his term of office;
- 3. The Town of Arborg shall pay to each Councillor a monthly indemnity of \$650.00 during her term of office;
- 4. The Town of Arborg shall pay to each member of Council \$0.00 for each hour actually and necessarily spent by him/her, under authority previously given by resolution of Council, in the performance of such duties, work or services as he/she is required or authorized under the resolution to perform within the limits of the Town of Arborg, and \$0.50 kilometer for each kilometer actually and necessarily travelled by the Councillor in the performance of the duties, work or services;
- 5. The Town of Arborg shall pay to each member of the Council authorized by resolution of Council to attend meetings and/or business beyond the limits of the Town of Arborg on the business thereof \$190.00 per day in addition to actual mileage and accommodation expenses for each day he/she is actually engaged in that business;
- 6. The Town of Arborg shall pay to a member of Council an indemnity of \$190.00 per day in addition to actual mileage and accommodation expenses for each day he/she is actually engaged in, travelling to, attendant at and returning from any such meeting of:
 - (a) Association of Manitoba Municipalities
 - (b) Federation of Canadian Municipalities; or
 - such other organization that in the opinion of the Council it is in the interest of the municipality to belong;
- 7. The Town of Arborg shall pay to a member of Council attending a full day meeting, as a representative of Council, within the Town of Arborg, an indemnity of \$190.00 per day, such meetings to be designated by Council;
- 8. The Town of Arborg shall pay to a member of Council an indemnity of \$21.50 per hour, including travel time, together with actual expenses, under authority previously given by resolution of Council to attend meetings of less than five hours duration, held outside the Town limits, except evening meetings, which will be paid an hourly rate;
- 9. The Town of Arborg shall pay to a member of Council a meal allowance up to \$70.00 per day, under authority previously given by resolution of Council, to attend meetings of five hours duration or more, held outside the Town limits;

- 10. The Town of Arborg shall pay to a member of Council a technology allowance of **\$135.00** per month.
- 11. All previous by-laws to provide remuneration to the Mayor and/or Councillors be hereby rescinded on the date this by-law takes effect.
